Last Meeting - April 6, 2009

The regular weekly meeting at the Morris Town House was called to order by President Jeffrey **Conroe**.  Rotarians and guests sat in rapt attention as Norwich attorney James Cushman reviewed the various "chapters" of the current bankruptcy laws in the United States. Cushman is one of the few lawyers in the area who specializes in bankruptcy work; he was recommended to MRC by local attorney Timothy Johnson. Jim's expertise is well-known with most of his cases coming from referrals.

Cushman said there was a flurry of cases before legislators changed the bankruptcy law in October, 2005. Now, with a declining economy, the number of cases has picked up again. Serious illness or loss of job frequently cause individuals to seek protection when their expenses exceed income. Depending on an individual's situation, certain essentials (like the filer's home) can be protected from creditors. Cushman listed the three types of creditors as 1) secured creditors, 2) taxing authorities, and 3) unsecured creditors. Several Rotarians recounted personal experiences of being unsecured creditors when filings occurred.

The vast majority of cases are filed under the three main chapters of the US Bankruptcy Code which are Chapter 7 (liquidation), Chapter 11 (reorganizations, usually corporations), and Chapter 13 (individual debt adjustment). Other chapters, specifically 8-10 which deal with railroads, municipalities, etc., are seldom mentioned these days. Recently, Cushman has been writing a number of petitions under Chapter 12, a special section of the law dealing with family farms. Under this plan, farmers are given 5 years of supervised help to eliminate their debt.
